

About Tecnologico de Monterrey

Tecnologico de Monterrey is a non-profit private university system. This system is composed by three Institutions: Tecnológico de Monterrey, Universidad Tecmilenio and Tec Salud.

Tecnológico de Monterrey is an Institution by society for society founded in 1943 by a select group of Mexican business leaders headed by Eugenio Garza-Sada and inspired by his alma mater, the Massachusetts Institute of Technology. Our current vision is leadership, innovation and entrepreneurship for human flourishing.

Universidad Tecmilenio is a university that fosters students' discovery of their life's purpose and Tec Salud is an academic health care Institution conformed by two academic health centers.

Tec and Tecmilenio have presence in 44 cities, with a total of 157,000 students, 67% with financial aid and an innovative talent-driven search and scholarship program for low income students.



Tec de Monterrey is a private non-profit multi-campus university distinguished globally for its academic excellence. education innovation, entrepreneurship, and global vision, along with its deep relationship with industry, and its ability to execute. Leader in research and patent applications among Mexican private universities.

With presence across 32 cities in Mexico and 18 international offices. the Institution than 61.000 has more enrolled undergraduate and graduate students. almost 11,000 faculty members, and more than 27,000 Sr. High School students served by 2,500 professors.

Tec de Monterrey has over 330,000 alumni. 22% are partners or founders of a company within three months of their graduation. 27% of the presidents and CEOs of the 200 most important companies in Mexico are Tec graduates.



The Institution has been accredited by the Commission on Colleges of the Southern Association of Colleges and Schools (SACSCOC) since 1950. According to the QS World University Rankings (2022), Tecnologico de Monterrey ranks 170th globally and among the top 30 private universities worldwide.

The Times Higher Education Latin America University Rankings (2022) ranks the institution 1st in Mexico and 5th in Latin America. Tecnologico de Monterrey is the only university outside the USA included in The Princeton Review & Entrepreneur magazine ranking of Top Schools for Entrepreneurship Studies (2022), placing 4th for undergraduate entrepreneurship programs.

Our global vision has led us to foster relations with international universities and to collaborate with them in several initiatives. We have mobility agreements with over 592 different Institutions in over 52 countries which has made possible that 34% of our students graduate with an international experience. Also, we have research and innovation agreements with around 20 highly ranked universities.

Tec has a seat on the board of several prestigious global networks including, SACSCOC, the Association of Pacific Rim Universities (APRU), Universitas 21 (U21), and member of the Worldwide Universities Network (WUN), Edison Alliance, among others.



Founded in 2002, Tecmilenio has presence in 27 cities across Mexico and over 61,000 students. Universidad Tecmilenio operates under the positive-university and competence-based model, and has close ties to diverse industries to foster students' discovery of their life's purpose and the skills to fulfill it. Tecmilenio has over 141,000 alumni.



It includes two academic health centers with twelve specialty institutes. First private academic medical center in Mexico with the goal of transforming the private medical practice into a patient-centered model by combining research, education and patient care. We provide healthcare services to over 122,000 patients per year.
